



# Main objective of Prindex

To develop a nationally representative, globally comparative dataset, available to all, with an approach and methodology that can be adapted to different contexts in countries & groups.




# What do we want to achieve with this data?

1. Influence change in design of national policies and programmes related to land & property.
2. Help to monitor impact of these policies & programmes – PTS as intermediary measure of success.
3. Contribute to tracking the SDGs (1.4.2 and 5.a.1) & other key development indicators.



# Methodology



- **140** countries worldwide
- Covering **96%** of the global population
- **168,000** adults (18+) interviewed
- Collected in 2018-2019
- Equivalent to **5.2 billion** people






# Where Which regions are most insecure?




# Where **Which** countries are most insecure?



# Who Insecurity by tenure type




# Who insecurity by location (rural & urban)




# Who insecurity by age








Securing Land and Property Rights

Property rights are a cornerstone of economic development and social justice. One fundamental way of understanding their strength is to ask people how secure they feel in these rights.


**1 LEVELS OF INSECURITY** The percentage of the adult population that feels insecure in their property rights




**2 WHO FEELS INSECURE** Insecurity by gender, population density, or tenure type

**Methodology** A nationally representative sample of adults 10 years or older in Colombia were asked about their perceptions and experiences with property rights and tenure security. Prindex is a global survey measuring perceptions of land and property rights. By developing a deeper understanding of how they work in practice, Prindex is helping build a world where everyone feels secure in their right to their home and land.



Prindex, an initiative of Global Land Alliance and Overseas Development Institute with support from DFID and Omidyar Network, is the first global measurement of peoples' perceptions of their property rights.

# The quest for secure property rights in Africa

Handing out title deeds is not enough



KHAYELITSHA


**B**UILDERS ARE busy outside Louisa Qangiso's house in Khayelitsha, a township on the outskirts of Cape Town. The 49-year-old is putting up eight studio flats in her backyard that she will rent out for 3,000 rand (\$177) per month. This could almost triple the value of her property, from roughly 570,000 to 1.6m rand. These are life-changing sums for Ms Qangiso, a grandmother whose warehouse job pays just 5,000 rand a month. "This is my dream come true," she says, holding back tears.

The dream is reality because of Ms Qangiso's grit—and because, unlike most
